

# Tariff

Our farm has two twin cottages, that totals to 4 duplex suits. Each of the room has a separate entrance and attached washroom along with an attic.

Each twin cottage can host a family 6-8 people comfortably. A couple can take up part of the twin cottage for spacious stay. An individual or artist can take up part of the twin cottage and convert the ground floor as his or her studio.

Our tariff for leisure activities are as follow:

We recommend a stay of minimum two nights to experience the off grid culture.

## Cancellation Policy

- We request 50% advance for blocking the dates for you.
- The balance 50% 24 hours prior to the visit.
- Cancellation made 30 days prior to the stay would get 100% refund
- Cancellation made 21 days prior to the stay would get 50% refund
- Confirmed booking cannot be postponed to any future dates.

# Terms of Booking

Our farm being an off the grid space, leads to few limitations & regulations.

- We do not have separate lodging boarding for drivers or nannies.
- We do not recommend check-ins post 5 pm.
- We like to maintain the tranquillity and thus do not allow late night parties with loud music.
- We do allow food in the rooms, as that would attract ants and insects.
- All rooms are strictly non-smoking. Hookah is forbidden.
- Consumption of drugs is forbidden and guests will be asked to leave the premises if found consuming or possessing drugs on the premises. No refund shall be processed if such an incident occurs.
- Children above the age of 8 years shall be considered another person.
- Extra bedding includes (mattress on pallets, pillow, sheets, and blanket).
- Being an off-grid place, in the unfortunate circumstances of bad weather, non availability of staff or technical glitches , we will process a refund within 24 working hours.
- We reserve the right to refuse a guest or representative entry and accommodation if, on arrival, management reasonably considers that the guest is under the influence of drink or drugs, is unsuitably dressed or is behaving in a threatening, abusive or otherwise unacceptable manner

# Indemnity
